Prerequisites: Successful completion of MATH 1324

Materials: College Mathematics 13th ed. by Barnett, Ziegler, Byleen. Suitable writing instruments and paper for taking notes and completing assignments. A calculator with exponential and logarithmic functions is required. Graphing calculators are allowed (the TI-89, TI-92, and TI-nspire models are strictly prohibited). Access to MyMathLab will be required for doing homework.

**Expected Learning Outcomes:** At the end of this course, students should be able to competently perform the following:

- Utilize functions and algebraic concepts to model realistic problems from business, economics and life/social sciences situations.
- Use concepts of limit and continuity to describe behaviors of functions and models.
- Use the derivative to analyze the local behaviors of mathematical models, and to understand other business and economics definitions
- Use the indefinite and definite integrals appropriately to describe mathematical models or create new models

**Assessment:** Grading will be done according to the standard 10 percent scale (i.e. 100% - 90% is an A, etc.) with assignments weighted according to the following scale

**Homework:** MyMathLab will be used in this course. Homework is expected to be done daily. Late work is not accepted.

Quizzes: Quizzes will be given daily. Problems will be taken directly from the homework assignment.

**Exams:** Midterm exams will be given during this course. Questions will be taken directly from assigned homework problems as the quiz questions. During exams cell phones, laptops, and other such objects should be turned off and put away. There is no tolerance for violations. *Makeup exams are not given*.

**Final Exam:** The final exam is comprehensive, and a required part of the course. Failure to take the final exam results in an automatic F. As the exam is comprehensive, your final exam grade is also your lowest possible course grade. The Final Exam will be given on Wednesday, May 9 at 5:30 pm

Civility in the classroom: Students are expected to assist in maintaining a classroom environment that is conducive to learning. Given that students will be asked to present material as a part of the course, and contribute openly in class, troublesome behavior will not be tolerated.
