Purpose of Course

This course will provide students with the practical experience in the operation of audio equipment, including both pre- and post- production needs. The student will gain knowledge of mixing boards, broadcast audio boards, microphones, audio recorders, and audio editing software. The student will also learn some of the terminology used in the audio recording industry. Upon completion of the class the student will have a basic understanding of audio and recording audio. The student will also understand how to record a podcast.

Course Objectives

Upon successful completion of this course, the student will be able to demonstrate a working knowledge of the following:

- 1. Identify audio equipment necessary for content production
- 2. Demonstrate understanding of effective sound editing techniques.
- 3. Operate studio equipment to create audio content.
- 4. Demonstrate basic announcing skills.
- 5. Knowledge of the audio files types and compressions

In this class the student will work on individual and group projects. It is important that the student attend class to be able to work on these various projects. The student will also learn to write scripts for the purpose of the projects. Creativity is expected from the student and is needed to be successful in the class.
