

SYLLABUS: ARTS 1313 FOUNDATIONS of ART – Spring 2022

Course Description: Introduction to the creative media designed to enhance artistic awareness and sensitivity through the creative and imaginative use of art materials and tools. Includes art history and culture through the exploration of a variety of art works with an emphasis on aesthetic judgment and growth. This course is not intended for Art Majors.

Course Type: This is a face-to-face and online course and offers face-to-face instruction with online assignments provided to supplement and enhance learning. Please log in to Blackboard and participate a minimum of two times per week to fully complete all posted module content and check Blackboard content and assignments. You should expect to spend a minimum of 3-6 hours per week on this course.

Dates: Important college dates can be accessed on the SPC website such as: Last day to Register, Withdraw Date, Holidays, and Final Exams. Dates for assignments will be announced in class, on Blackboard and accessible online.

Course Objectives

- To provide direction for developing a sound program of education in art, complying with the guidelines established by the State of Texas.
- To incorporate the theories of art education and methodology with practical helpful assistance to teachers and students preparing to teach art to children and integrate art as a reinforcement for other subject areas.
- To gain knowledge relative to discipline-based art education and its application to elementary art forms.
- To understand the principles of assessing student artwork.
- To understand health and safety in the classroom.
- To use art adaptability in applications to a variety of subjects.

Course Structure: The course structure will include lecture, discussion, interaction, demonstration and hands-on work relative to the teaching of art in the public schools.

Course Requirements

- Attendance: Attendance is expected when possible. While no penalty is given for absences due to COVID-19, participation and engagement are required to pass. That includes turning in assignments and communication.
- Participation: students are expected to participate in discussions (in-person, online), exercises, at-home, and field activities.
- *If a student is continuously unresponsive in participation and to communication, a final warning email will be sent to that student and a week to respond to request. If no response is received at that point the student will be submitted to administration for course withdrawal.
- Preparation: Students should come to class prepared, having viewed and/or read the assigned material. The students are expected to take notes on all materials presented.
- *Students are responsible for assigned video viewings and reading content even if not covered during the lecture.
- Quizzes: Made up of matching, fill-in-the-blank, multiple choice, and short answer questions. There are (usually) three (3) quizzes, each will have a review prior. No scantrons will be used.
- Texts: There is no required textbook for this class. Readings and videos will be provided by the instructor.

Grading Criteria

- Class Participation: Input in class discussions as well as performance and work ethic in class activities and assignments including Class Civility.

Discussions require a calm and open-minded dialogue to consider different points of view. Civility and respect will be required at all times. There will be zero tolerance for inappropriate behavior.
 - Come to class prepared with preliminary work so you can participate fully when class begins.
 - Individual behavior and attitude can greatly influence the class mood as a whole. Please conduct yourself in a way that promotes the productivity of the entire group.
 - Academic Honesty: The faculty is strongly committed to upholding standards of academic integrity. These standards, at the minimum, require that students never present the work of others as their own.

COVID-19 Statement: General Guidance for Testing of and Exposure to COVID-19 – Rev. 8/19/2021 All faculty, staff and students who are experiencing COVID-19 symptoms will be asked not to attend class or work and to contact their healthcare provider immediately. SPC Return to Campus Plan – 8/19/2021 South Plains College will not track exposures based on close contact, and will not quarantine these exposed individuals. Individuals who are exposed to someone with a known positive COVID-19 test are encouraged to either self-quarantine for the recommended time period identified by the CDC or wear a face covering for the same time period while in an SPC building. Neither of these will be required but are strongly encouraged. Faculty will be notified of any positive exposures in their class. They will accommodate the individual being quarantined as well as any other students who are self-quarantined due to exposure.

Recommendation for Testing – Here is some information that may be helpful to make a decision about getting tested:

- Most people have mild illness and can recover at home without medical care. Contact your healthcare provider if your symptoms are getting worse or if you have questions about your health.
- Decisions about testing are made by state and local health departments or healthcare providers.
- If you have symptoms of COVID-19 and are not tested, it is important to stay home.

Anyone with a known exposure should wear a mask for 10 days and should seek a COVID-19 test on day five after exposure. If you test positive or develop symptoms, you should immediately self-isolate and seek a COVID-19 test. Anyone who tests positive is required to self-isolate for five days. Following the five-day isolation period, if you are asymptomatic or your symptoms are resolving, you may return to work or class but should wear a mask for five additional days. If you are still symptomatic, please contact DeEtte Edens, Associate Director of Health and Wellness, prior to your return date.

Other medical and mental health needs: As instructor, I am committed to working with students with pre-existing medical and mental health needs, as well as new needs that may arise within the semester. I encourage you to reach out to me as early as possible to discuss any adjustments you think may be necessary in this course.
